New Procedure

ELIGIBILITY The Collectors' Gallery is an excellent opportunity for all Artist Members to display and sell their artwork in the summer months. This is a juried show which is open to all Artist Members working in painting, sculpture, photography, mixed media and works on paper, but work is shown on a rotating basis during the season, and there is no formal opening reception for this show.

RECEIVING DATES & COMMISSION INFORMATION

You are invited to submit *two new works*. There is no guarantee of acceptance of either work. **The SVAC receives 40% commission on all artwork sold and on all commissions, and 30% of all sales resulting from the Arts Center directing clients to artist's studio or website .**

FOR THE FIRST TIME WE WILL BE JURYPING THIS SHOW BY CD AND SLIDE ONLY, IN ORDER TO ACCOMMODATE ARTISTS WHO LIVE A DISTANCE FROM THE ARTS CENTER. THIS IS ON A TRIAL BASIS TO SEE IF IT IS MUTUALLY BENEFICIAL. PLEASE SEE SEPARATE SHEET WITH ENTRY FORM, 'CD/SLIDE SUBMISSION PROCEDURE' FOR MORE INSTRUCTIONS. WORKS, ONCE ACCEPTED, WILL STILL NEED TO BE DROPPED OFF IN PERSON AND PICKED UP ON THE DESIGNATED DATES. WE REGRET THAT WE CANNOT ACCEPT SHIPPED WORK.

DROP OFF DATES

Work accepted by CD/Slide needs to be dropped off at the SVAC Thursday, June 3rd, Friday, June 4th (11-4pm) and Sunday, June 6th (1-3pm)

PICK UP DATES

All work shown needs to be collected **September 18th, 21st or 22nd (11-4)**,to coincide with drop off for the **National Fall Exhibition.**

MEDIA AND SIZE

The size of paintings and photographs may not exceed 35" X 45" over-all dimensions. Oil, acrylic, and mixed media work must be professionally framed, **READY FOR INSTALLATION**, with eye-screws and wire. Watercolor, graphite art, pastels and photographs must be matted and framed with glass and ready for installation as well. All matting and framing must be clean and professionally presented. Sculptural work **MUST NOT EXCEED 75 lbs**, with the longest dimension no more than **SIX FEET**. Any submitted work which does not meet these guidelines will not be accepted.

Enclosed are your **entry form** and **two label sets** marked "**Collectors Gallery**". Please be sure to attach appropriate label set to the top left hand corner on the reverse side of each work that is accepted. Place labels on the bottom of the base of sculptures. Do not detach any portion of the label affixed to the piece. It will be used for recording purposes.

CD/ Slide Submission Procedure

CDs and slides must be accompanied by a current resume, and the entry form on this sheet, which needs to identify clearly the art works submitted for review, with title, medium, framed dimensions and price. The CD/ slide must show the frame of the painting/ drawing/ photograph. Up to two original works only can be accepted by each artist. The CD must be compatible with Microsoft Windows programming – no work can be accepted if it cannot be viewed by the jurors, or if all details on the entry form below are not filled in.

CDs/slides, entry form and resume must be sent to the SVAC by Wednesday, May 12th, for presentation to the jury on Saturday, May 15th. Mark envelope “ Collectors”

Artists submitting CDs/slides are requested to phone the SVAC on Thursday, May 20th, to find out if work is accepted. The Arts Center will not contact the artists.

Accepted work needs to be dropped off on June 3rd, 4th and 6th, as indicated in the accompanying Collectors Gallery prospectus, with label sets marked ‘Collectors Gallery’ filled in and attached to the back of each piece. Work not dropped off at that time cannot be included in the show. Your CD/ slides will not be returned to you, unless you enclose a self-addressed stamped envelope. The SVAC does reserve the right to reject any works that are not properly framed and ready for hanging with wire on the back, or which do not match the quality of the image submitted on slide or CD and are not compatible with our standards.

Liability:

By signing below, the artist acknowledges that Southern Vermont Arts Center Inc. shall use all reasonable care in the handling, storage and display of the artist’s work submitted for Exhibition. Artist also acknowledges that it is the Artist’s sole responsibility to adequately insure his or her work against loss due to damage, theft or other while on the property at Southern Vermont Arts Center or while in transit from said property and further agrees to hold harmless, Southern Vermont Arts Center., Inc.
